## Campus Security Crime Report

To:All Students, Staff and FacultyDate:October 01, 2021

During this and the previous three calendar years, PROSPECT COLLEGE has had no occurrences of robbery, arson, arrests for violations of liquor and drug law violations, and illegal weapons possession, burglary, aggravated assault, forcible and non-forcible sex offenses, murder and non-negligent manslaughter and negligent manslaughter on its campus. Furthermore, there were no occasion where a person was not arrested but referred for campus disciplinary action for liquor, drug, and weapons law violations.

PROSPECT COLLEGE campus policy regarding procedures for reporting crimes and other emergencies occurring on campus and the policy to respond to such incidents are as follows: Anyone witnessing any violation of law on PROSPECT COLLEGE campus must report it to the school director or another staff member. If for any reason, the violation cannot be reported to PROSPECT COLLEGE management or staff, they must be reported to local law enforcement authorities. PROSPECT COLLEGE will distribute information on such violations to its students and employees. PROSPECT COLLEGE will prepare and distribute statistical disclosure reports on such violations by their type to its students and employees and other local or federal agencies as needed on an annual basis. PROSPECT COLLEGE will include voluntary or confidential reports made by victims or witnesses in its annual disclosure of crime statistics. All violations will be fully documented by PROSPECT COLLEGE and include date and nature of violation and other pertinent details. PROSPECT COLLEGE monitors and reports all violations and crimes committed on its campus to DC Metropolitan Police department or other local or federal enforcement agencies as required by law.

PROSPECT COLLEGE students and employees are encouraged to act responsibly for their own security and the security of others. Students or employees involved in the possession, use, and sale of alcoholic beverages or illegal drugs on PROSPECT COLLEGE premises will be subject to immediate withdrawal from the PROSPECT COLLEGE program, or termination of employment, respectively. PROSPECT COLLEGE will report any such violations to local and federal enforcement agencies as appropriate and required by law. PROSPECT COLLEGE offers its students and employees information about drug and alcohol-abuse education programs, and educational programs to promote the awareness of rape, acquaintance rape, sex assault prevention programs, and other forcible and non-forcible sex offenses that are available through the DC government Department of Health and Human Services, Government of the District of Columbia. When a sex offense occurs on PROSPECT COLLEGE campus, the school director or another staff member must be notified immediately. If for any reason, the violation cannot be reported to PROSPECT COLLEGE management or staff, they must be reported to local law enforcement authorities. Every attempt must be made to preserve evidence for proof of a criminal offense. PROSPECT COLLEGE personnel will assist the student in notifying these authorities if requested. If requested by the student, PROSPECT COLLEGE will also provide information on availability of off-campus counseling, mental health, or other student services for victims of sex offenses. PROSPECT COLLEGE will change a victim's academic situations after the alleged sex offense if changes are requested by the victim and are reasonably available. Both the accuser and the accused are entitled to the same opportunities to have others present during a disciplinary proceeding, if any is held, and will be informed of the school's final determination of any school disciplinary proceeding with respect to the alleged sex offense and any sanction that is imposed against the accused; and sanctions the school may impose following a final determination of a school disciplinary proceeding regarding rape, acquaintance rape, or other forcible or non-forcible sex offenses.
